ORDINANCE NO. 2015-6

"AN ORDINANCE OF THE VILLAGE OF THAYER, SANGAMON COUNTY, ILLINOIS ADDING SECTION 16-11-12 TO THE CODE OF ORDINANCES OF THE VILLAGE OF THAYER, SANGAMON COUNTY, IL PROVIDING FOR THE REGULATION OF TRASH PICKUP and RECYCLING WITHIN THE VILLAGE LIMITS OF THE VILLAGE OF THAYER,"

WHEREAS, the Board of Trustees of the Village of Thayer, Thayer. Illinois, deems it necessary for the public interest that the present, general and permanent ordinances of the Village of Thayer be amended, and;

WHEREAS, it is desirable that the Village of Thayer regulate trash pickup and recycling within the Village limits of the Village of Thayer.

NOW. THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF THAYER. THAYER. ILLINOIS, AS FOLLOWS:

Section 1: Individuals and businesses who have trash pickup and recycling pickup scheduled for pickup at their residence or business may not put their trash cans or bins or their recycling cans or bins out at the street or in the alley or wherever their designated place is more than twenty-four (24) hours before the scheduled pickup and must remove said trash cans or bins back to the house or place of business within twenty-four (24) hours after pickup by the trash hauler or recycler.

Section 2: Any person who violates this ordinance or any part thereof, shall be guilty of a municipal ordinance violation and shall be fined as follows: 1) No fine but receive a warning for a first offense: 2) The sum of seventy-five dollars (\$75.00) for a second offense: 3) The sum of one hundred fifty dollars (\$150.00) for a third offense; 4) the sum of two hundred twenty-five dollars (\$225.00) for a fourth or subsequent offense, per offense thereafter.

Section 3: This ordinance shall be in full force and effect at the earliest period provided for by law.
