The Thayer Village Board met in regular session, Monday, December 13, 2021, at 7:00 p.m. at the Village Hall.

**Call to Order** – Rob McMahan called the meeting to order at 7:05 p.m.

**MINUTES**

The draft written minutes from November 8, 2021, were distributed. On page 3 the quote for the camera in the police truck should be \$2,805.45. *Paula made a motion to approve the minutes with that correction. Bobbie seconded. Motion passed unanimously.*

Utilities – Ron  
Chief got in touch with him about some lights. He talked to Ameren and he is not sure if they are fixed yet. There were two water breaks.

Building & Grounds – Mac  
Cameras have been installed at Village Hall. Santa is coming this Friday to the Community Building. Thayer was well represented at the Virden Christmas parade. Both Chief Sullivan and John were there. Nothing more has been done on the garage door at the community building.

## **Police Report**

Chief Sullivan submitted a written report.

***Mac made a motion to approve committee reports as submitted. Ron seconded. Motion carried unanimously.***

## **Requests to Address Board from Citizens**

Eric addressed the board regarding a burn citation that he received.

Chief Sullivan read his report on this matter. He had issued a \$250 ticket.

Ron suggested we post the ordinances on the web page so that more people would be aware of it.

Brenda Eller addressed the Board regarding issues they are having with someone in their neighborhood. Chief Sullivan said he has issued written warnings and all have been corrected each time. He has not received any new reports. He advised that the best thing to do is call Sangamon County Dispatch.

Patrick came to follow up on his dog barking complaint. Chief Sullivan said in the video there is not a continuous barking. There have not been any complaints from other neighbors. Patrick will share other videos with Chief.

## **OLD BUSINESS**

The heater has not been put in the water room yet.

The cameras have been installed at the Village Hall.

The camera in the police vehicle is installed.

Ron got a phone call from Ms. Cloyd. She wants the information again about her fines and water bill. He has her address and phone number. John can get the water bill. Chief has the fine information.

## **NEW BUSINESS**

Chief Sullivan said the blue car needs the left front control arm replaced. We had the right side repaired in 2018. He submitted an estimate for repair - \$535.34. ***Mac made a motion that we do the repair. Paula seconded. Motion carried unanimously.***

Paula suggested we purchase salt for the winter and John attach the salt spreader. John will call and check on getting salt.

Burning Ordinance – ***Mac made a motion that we mail the burn ordinance with the water bill and that Chief Sullivan determine some other ordinances for Kay to put on the web page. Bobbie seconded. Motion carried unanimously***

***Mac made a motion to drop the ticket. Paula seconded. Motion carried unanimously.***

Otter Lake is raising the water rates. It is a 5-year plan that will go into effect in March. We will discuss at the next meeting.

We were approved for our new water contract.

Ameren is going to monitor the voltage at the sewer plant.

No parking signs were posted on Teak Street.

***Paula made a motion to adjourn. Bobbie seconded. Motion carried unanimously.*** The meeting adjourned at 8:20 p.m.
