The Thayer Village Board met in regular session, Tuesday, October 11, 2022, at 7:00 p.m. at the Village Hall.

Call to Order – Rob McMahan called the meeting to order at 7:00 p.m.

MINUTES

The draft written minutes from September 12, 2022, were distributed. *Mac made a motion to approve the minutes as written. Ron seconded. Motion carried unanimously.*

EXPENSE PAYABLES

A written report was distributed. *Mac made a motion to accept the expense payables as submitted. Kera seconded Motion carried unanimously.*

COMMITTEE REPORTS

Building & Zoning – Paula – No report

Streets & Alleys – Ray

No report. Tim had some questions on alleys, and he will cover that in his report.

Health & Welfare – Bobbie - No report

She has been keeping informed by Chief Sullivan and most will be in his report.

Utilities – Ron Smith

A couple people mentioned the side by sides but that is an issue to be handled by Chief Sullivan. Chief said there is a checklist in our ordinances. Guidelines would be the same as golf carts. Mac said the light by Mick & Mary's is out again. Rob said they haven't fixed the light by Brumfield's either.

Finance – Kera Pusch – No report

Building & Grounds – Mac McGlothlin

Building has been rented several times. John got covers for some of the storm drains. John got estimates on the shed near the ballpark. The sheds were removed from the alley on East Elm Street. Trunk or Treat is October 30th from 5-7 pm.

Water Report – John Ulery read aloud and submitted a written report for September.

Police Report - Chief Sullivan read aloud and submitted a written report for September. There were a couple issues where citations and/or warnings have been issued.

Bobbie made a motion to approve the committee reports. Ron seconded. Motion carried unanimously.

Requests to Address the Board

Mark McGrath /Ashleigh Koerner and Douglas Burns were present to discuss alley behind their homes that is all grass. Kids play back there and there should not be anyone driving back there. To drive down any alley it would need to be rocked. Board must approve to have an alley rocked. Rob said we have had issues in the past with junk being hauled in there. Bobbie does not like to have the alleys rocked because it builds up and causes mowing issues. Ron said there is an ordinance on parking in the alleyway. Mac said it is a 2-hour limit. Rob said we will stick with the ordinance. Chief said he has an updated alleyway ordinance for review tonight.

OLD BUSINESS

Lawn mower has been delivered.

Lightning Strike – all has been repaired.

NEW BUSINESS

Garage repairs – We still need bids or costs to have John fix it. Ron and John will look at it and bring numbers to the next meeting.

Ray asked what it would cost to put up a shed behind the Village Hall. Rob said Paula was going to investigate that.

Sangamon County Zoning – ***Ron made a motion to table the Sangamon County Building & Zoning issue. Mac seconded. Motion carried unanimously.***

Alley behind Sycamore – ***Doug Burns requested permission to rock it. Mac made a motion that we do not permit the alley to be rocked. Kera seconded. Motion carried unanimously.***

Appointment to the Water Commission. ***Mac made a motion that John Ulery be appointed to the Water Commission. Ron seconded. Motion carried unanimously.***

Chief Sullivan presented a draft ordinance for the Alleyways/Service Roads. He will add language about a time frame for parking in an alley. Rob suggested no more than 24 hours.

A bill from Adams Pest Control bill was received for \$250 for one year. It expires 11/10/22. He baits and sets the traps twice a year for termites. ***Ron made a motion to pay the bill. Kera seconded. Motion carried unanimously.***

Mac made a motion to adjourn. Kera seconded. Motion passed unanimously. Meeting adjourned at 8:25 pm.
